> Track changes in your current accounts and instantly determine the amount of interest payable or receivable per entity.

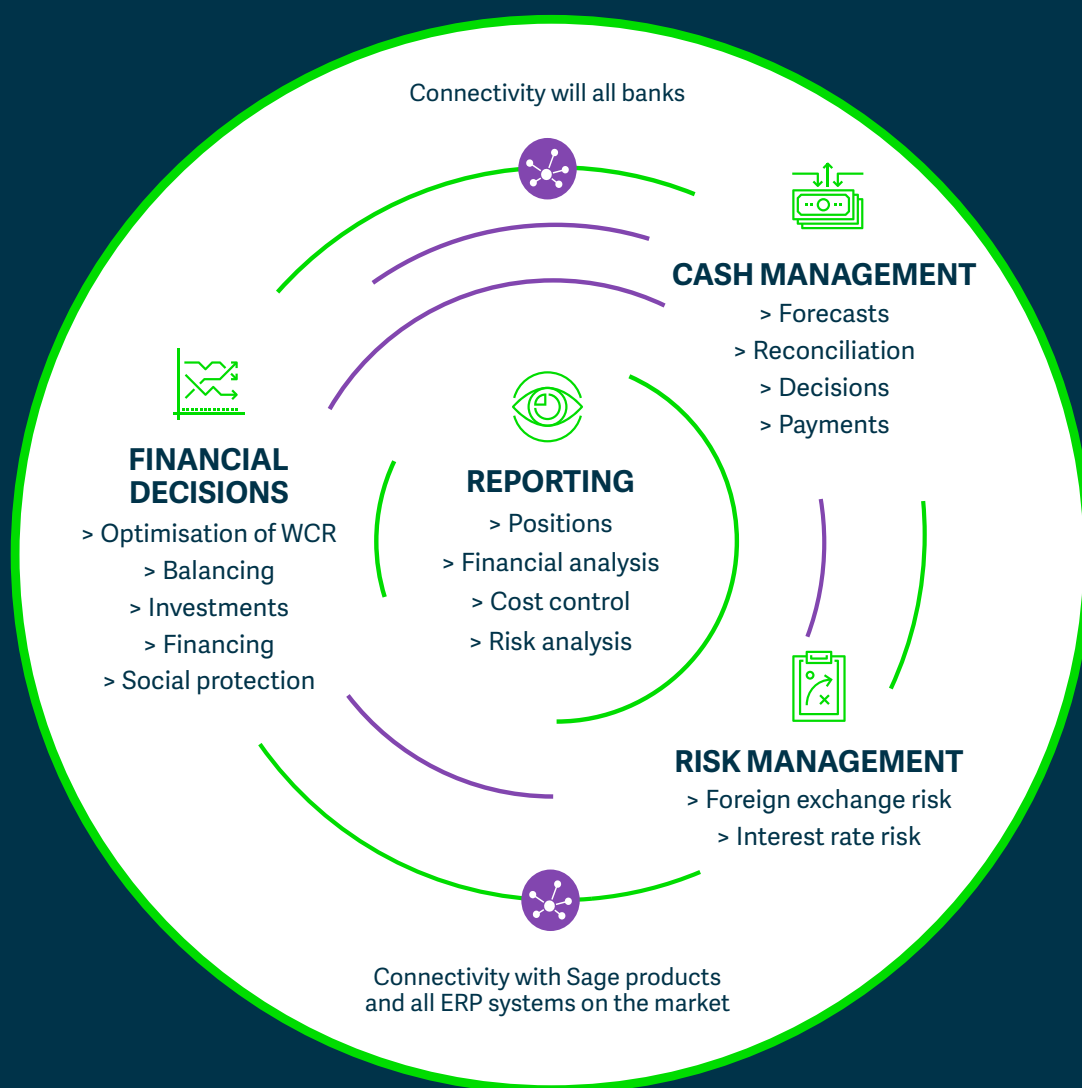
Increased productivity
